2	Give a short description on the types of intellectual property rights which are registrable in your jurisdiction and the validity period.	<p>Trade Mark The registration is valid for 10 years from the date of the application and may be renewed every 10 years.</p> <p>Patent for industrial invention The Patent gives the exclusive right to use the invention for 20 years, without possibility to renew it.</p> <p>Industrial Design</p> <p>a) Italian Industrial Design: The registration is valid for 5 years from the date of the application and may be renewed every 5 years.</p> <p>b) International Industrial Design: The registration is valid for 5 years from the date of the application and may be renewed for a maximum of 15 years only.</p> <p>c) EU Industrial Design: The registration is valid for 5 years from the date of the application and may be renewed for a maximum of 25 years only.</p> <p>Geographical Indications In Italy not all Geographical Indications can be registered (the possibility of such registration depends upon the relation between the product and the geographical indication). If it is possible to register them, the registration is valid for 10 years from the date of the application and may be renewed every 10 years.</p>
